

TOLL AND INTEREXCHANGE SERVICE

1. STATEMENT OF CONCURRENCE

The above named companies assent to, adopt, and concur with the rates of the New England Telephone and Telegraph Company (d.b.a. Verizon), on file with the Maine Public Utilities Commission, as regards toll service, rates, terms and conditions, including the Pine Tree State Service optional calling plan.

2. MESSAGE TOLL SERVICE

The Company concurs with and adopts as its own schedule, the effective Message Telecommunications Service Schedule of VERIZON for jointly provided intrastate services filed with the Maine Public Utilities Commission (See VERIZON effective Schedule).

3. MESSAGE TOLL TELEPHONE SERVICE FOR DISABLED PERSONS

A. GENERAL

- (1) Reduced message toll telephone service charges apply where a residence service customer or a member of a residence customer's household has been certified as having a disability that requires the use of a Telecommunications Device for the Deaf (TDD/TTY) for communication over the telephone network.
- (2) TDD is a generic term describing keyboard devices specifically designed or modified for the purpose of assisting deaf people in communicating with others over the telephone network. These include such devices as teleprinters or other keyboard units, which use cathode ray tubes (CRTs) or light emitting diodes (LEDs) to display messages. These devices may also be used by persons who, because of other disabilities, e.g., impaired speech, require a keyboard and visual display to communicate with others over the telephone network.
- (3) Certification of the disability requires the completion of an application form approved by the Public Utilities Commission. An application must be renewed every two years.

3. MESSAGE TOLL TELEPHONE SERVICE FOR DISABLED PERSONS
(Cont'd)

B. APPLICATION OF CHARGES

(1) A 70% rate reduction will be applied to intrastate toll calls made on lines, or via credit cards assigned to lines, used for making calls to and from certified deaf, hard-of-hearing or speech-impaired persons who must rely on teletypewriters for residential telephone communications. In addition, the 70% rate reduction will apply to all calls using the state telecommunications relay service. This reduction will also apply to intrastate toll calls made by agencies, certified by the Division of Deafness of the State of Maine Department of human Services as eligible to receive a discount, while providing vocal relay services to deaf, hard-of-hearing or speech-impaired person, as well as community service centers serving deaf, heard-of-hearing or speech-impaired persons, certified by the Division of Deafness as eligible to receive a discount.

(2) Reduced charges apply to messages subject to a discount under Selective Calling, NETSAVER Calling, Business Link, Block-of-Time and Extended community Calling Service.

Under Pine Tree State Service, reduced charges apply to the two hours per month cumulative message time. This period of time will be increased from two hours per month to six hours and forty minutes to accomplish the discount of 70%. Reduced charges also apply to message time in excess of the allowance.

(3) Customer dialed station-to-station and customer dialed credit card calls to a customer who is certified as having a disability, as specified in 409.1 preceding, will receive a 70% discount on the applicable charges upon request to the Company or billed and identified calls made during each billing period.

4. INTRALATA CALL COMPLETION OPERATOR SERVICES

The following charges will apply to automated operated assisted intraLATA calls:

(A)	Calling Card	\$0.21/per occurrence
(B)	Collect	\$0.25/per occurrence
(C)	Bill to 3 rd Number	\$0.25/per occurrence

SELECTIVE CALLING SERVICE

A. GENERAL

- (1) Selective Calling Service is offered, subject to availability of facilities, as a supplement to one-, two-, and four-party business or residence access line service for all the exchanges.
- (2) Selective Calling Service is offered to business customers provided that all lines at the same premises are arranged for Selective Calling Service with the same selected exchanges or localities.
- (3) This service permits calling at a discounted rate to a maximum of ten exchanges, selected by the customer, outside the local service area, but within the State of Maine, not exceeding the maximum distance in the third toll mileage band.
 - a) For the purpose of determining rate distances, a Vertical "V" and Horizontal "H" coordinate system is used. The V-H system consists of a series of coordinates which represents a theoretical grid of vertical and horizontal lines covering the State of Maine. The spacing between these lines is about 1,670 feet, and an intersection of any two grid lines represents the center of an area approximately 1/10 of a square mile designated by two coordinates.
 - b) The location of the rate center expressed in latitude and longitude is converted mathematically to its grid location, that is, Vertical "V" and Horizontal "H" coordinates. These coordinates permit calculation of the distance between any two such rate centers.
- (4) Selective Calling Service rates apply only to customer dialed station-to-station sent paid calls and Telephone Company operator completed station-to-station sent paid calls when facilities are not available for customer dial completion. The rates also apply to operator completed station-to-station sent paid calls for handicapped persons unable to dial calls because of their handicap. All other calls including calls made outside the specified time periods, will be billed as regular toll messages.

A. GENERAL (Cont'd)

- (5) The Selective Calling Service usage discount applies during the following time periods:
- a) Mondays through Fridays — From 12:00 Noon to, but not including 9:00 AM.
 - b) All day on Saturdays, Sundays, and on Thanksgiving Day (the fourth Thursday in November), Christmas Day (December 25), New Years Day (January 1), Independence Day (July 4), and on Labor Day, or on resulting legal holidays when Christmas, New Year's or Independence Day legal holidays fall on dates other than December 25, 1, or July 4, respectively.

B. Monthly Rates and Usage Discount

Selective Calling Service is provided at rates that concur with the rates of Verizon which are in addition to the rates and charges for the associated access line service, other associated services and the Service Order Charge located in Section 6. There is a usage discount of 50% of the appropriate dial station-to-station toll charge.

C. Limitations of Services

Selective Calling Service is not available

- (1) On Foreign Exchange service
- (2) For person-to-person, collect, credit card, third telephone number, conference, or other calls which normally require an operator.
